History Made

White City Water Company was a private water company established in 1955. It was in the ownership of the White and Papanikolas families until the White City Water Users (created July 10th 1991) purchased it through the creation of The White City Water Improvement District. The District was created by Salt Lake County Commission, December 1993, as an Independent Improvement District. The White City Water Users, petitioned the County Commission to create the district to enable them to purchase the company.

The Water Users spent countless hours in meetings, having fund raisers, petition drives, lobbying on capitol hill, doing never ending research to gain the knowledge and opportunity to purchase White City Water Company.

Their hard work and goal was finally realized
February 13, 1995.

Commercial Farming



We are excited to report that Salt Lake County has leased County-owned lands to local farmers for food production. The parcels are located in Draper and Holladay. [Tagges Famous Fruit](#) has leased approximately 5 acres north and east of the Holladay Lion's Center Recreation. Thayne and Cari Tagge have been farming along Utah's Fruit Row in Perry for several years (one of their orchards is pictured above). They are excited to have 5 acres close to their home in Holladay and to provide residents with fresh locally grown produce. PROGRAM HISTORY

In 2009 Salt Lake County began a new Urban Farming Initiative. Publicly owned lands that are currently lying fallow will be considered for lease for the purposes of growing fruits and vegetables.

- Preserve agricultural land to meet the nutritional needs of present and future generations
- Support local farmers
- Protect the food supply
- Promote the use of biofuel

Biofuel

Urban Farming and Fuel (UFF)

FreeWays to Fuel (F2F) and Salt Lake County Mayor Corroon's office have been working together to develop a pilot project using county and city owned land for biodiesel feedstock production. F2F is a Utah originated and based national alliance designed to investigate the use of non-traditional agronomic lands such as roadsides and airports for the growth of biofuel. Earlier this year, Salt Lake County, Salt Lake City



Public Utilities, the South Davis Sewer District, Utah State University and the Church of Jesus Christ of Latter-day Saints partnered to begin a biofuel feed-stock pilot project on 20 acres of dry farmland owned by Salt Lake City just southwest of the



Salt Lake International Airport. The purpose of the pilot project is to explore how publicly-owned lands unsuitable for traditional farming can grow crops that can be converted into biodiesel, as well as to explore the recycling of biosolids (generated

from wastewater treatment processes) through their use as fertilizer on the dry farm. Work began in March 2010 to prepare the seedbed for planting, and the safflower feedstock will soon be ready to harvest.

In August 2010, representatives from the U.S. Army and the National Biodiesel Board met for a site tour to explore the possibility of creating similar project on military land across the country. To read more about this click [here](#).

SPECIAL SERVICE DISTRICT #1 (SANITATION) **WEEKLY RECYCLING IS COMING!**

Beginning September 1, 2011, residents in our service area will begin receiving weekly recycling collection. Residents will no longer have to remember which week to place their recycling cans out at the curb! Recycling will be collected each week on your regular garbage collection day.

A recent survey indicated that 69% of district residents were in favor of weekly recycling collections. This is a 28% increase since our last survey in 2009. As residents understand the benefits of recycling they are asking for more convenient ways to recycle, including more frequent recycle pickups.

Implementing weekly collections also follows the waste collection industry trends to Reduce, Reuse and Recycle. Recent waste audits revealed that depending on the season, 30% to 60% of the volume of garbage collected could have been recycled.

The benefits of recycling include saving our natural resources, such as fuel, water, energy and raw materials. Recycling creates jobs with five times as many jobs than land filling. Recycling extends the life of the landfill. Every ton of plastic, paper, metal and glass we keep out of the landfill prolongs its life and saves money in dumping fees.

Citizens Police Academy

The Citizen's Police Academy (CPA) is a ten-week program designed to give participants a working knowledge of the Unified Police Department. It consists of a series of classroom discussions and hands-on scenarios. Training is held one evening a week. There is one academy class each year and each class size is limited to approximately 25 students. There is no cost to anyone who enrolls.

The goal of the CPA is to create a better understanding, improve communication, and partnership with the citizens and the Unified Police Department through education. Community Oriented Policing plays an important role in reducing crime in any community. Therefore the UPD instituted the CPA to improve communication and obtain input and support throughout the citizens they serve. It is our hope that graduates of the CPA become partners with us in identifying problems and solutions to the crime issues that are affecting our community.

Who attends the CPA?

Citizens in the service area of the Salt Lake County Sheriff's Office are all openly invited to enroll. Lawyers, teachers, bankers, homemakers, students and others have attended our classes.

When do classes meet?

Currently, the Sheriff's Office hosts one academy session per year. They meet in the evening hours one night a week for ten weeks.

What subjects are covered?

Classes include, but are not limited to:

- UPD Policies
- Firearms Training
- Non-Lethal Weapons
- Basic Handcuffing
- DUI Investigations
- Canine
- SWAT / Special Operations
- Traffic Stops / High-Risk Stops
- Basic Legal Block / Juvenile Law
- Domestic Violence
- Building Searches
- Traffic Accident Investigations
- Do I get to go on a ride-along?

Yes! The highlight of the academy is the four-hour ride-along participants are invited to attend. Students will ride for half a shift with an on-duty uniformed officer while they are out on patrol. Students will not participate in any actions.

This is an observation period only.

Do I GRADUATE with a certification?

The CPA is an educational tool only. At the end of the course participants will have a better knowledge of how the UPD works and what a police officer does on a day-to-day basis. There are no certifications given during this course.

What is the cost?

The CPA is just one of the classes the UPD offers to the community at no cost.

Who do I contact to participate?

The Citizen's Academy is limited to 24 people per class and

Report

[Report graffiti to the UPD](#) using via email, phone, or our online form.

Remove

The UPD can provide you with [free graffiti removal supplies](#) and can even assign an officer for protection during removal.

Re-group

Most graffiti perpetrators tire easily if graffiti is removed quickly (ideally within 24 hours). By [organizing a neighborhood group](#), you can respond quickly to remove new graffiti and discourage further incidents. Our mission is to provide sustainable integrated waste and recycling collection services for the health and safety of our community...because not everything fits in the can!

We provide services to residents in the unincorporated county and Herriman, Taylorsville, Holladay, Cottonwood Heights, and parts of Murray.

Green waste

Currently Salt Lake County Sanitation does not collect green waste in curbside cans. One of our goals is to divert as much recyclable material from the landfill as we can including finding ways to manage green waste: grass clippings, yard waste, fruit and vegetable scraps, and branches. Landfills

We are not a landfill. There are two landfills in Salt Lake County.

White Towers Swimming Club

The sounds of laughter and squeals can be heard almost every day. Music fills the air. It's the sound of joy from the only swimming pool in White City. It's White Towers Swimming Club and it's probably been around longer than most White City and Sandy residents. Amazingly, many residents don't even know it exists. Well, the secret's out. Be cautious, though, because extreme fun happens there. Once you've experienced the exciting yet relaxing atmosphere of White Towers, you'll be back for more.

White Towers is an outdoor pool facility located on the corner of Carnation Drive (1000 East) and Larkspur Drive (10400 South). White Towers is a little-known non-profit community pool in White City that is owned and managed by the members and a board. It started out initially in 1961 as a members-only club but is now open to the public and celebrates its 50th anniversary in 2011.

The season opens each year on Memorial Day weekend and closes on Labor Day. The pool slopes from 3 feet to 10 feet in depth. It has a staircase entrance, a diving board, and for small children there is a 2- foot deep walled-off section with a separate staircase entrance. The well-stocked snack bar is very enticing so come prepared.

Admission rates are extremely reasonable. Daily passes are only \$3.00 for the entire day! A summer pass for an individual is \$75.00. A family pass for the entire summer is a great bargain and can be purchased for \$175.00. A 'family' is defined as immediate family members living in one household. Weekly and monthly passes are also available for families. The ultimate deal for the summer is the Membership Pass. For only \$295.00 this pass includes married children and grandchildren in addition to immediate family members. There has even been a family that has held a White Towers membership each year since the pool opened its doors in 1961. Many other families have been members for over 25 years and in some cases the children and then subsequently the grandchildren have grown and obtained memberships or passes of their own. This generational use is such a testimony

to the quality of fun the pool can provide. These are memories that last a lifetime.

The most popular use for the pool is private pool parties. The entire facility can be reserved by the public for private use. This includes use of the pool, enclosed pavilion, foos ball and air hockey tables, BBQ grills, and fire pit. The facility can accommodate 250 people.

Private parties are \$125 for each 2-hour block and reservations are offered from noon to 10 p.m. each day of the week. An additional \$50 is charged for more than 30 guests. A lifeguard is available for an additional fee. Children under the age of 14 are always required to be accompanied by an adult whenever a life guard is not present. Children in diapers are required to wear swim diapers and plastic pants.

White Towers exists solely by any money brought in from passes, pool rentals, and donations. Each year endless hours are performed by volunteers and board members on improvements, repairs, daily pool and facility cleaning, snack bar coverage, and the state-required chemical level checks throughout the day. Many maintenance services and items for the facility have been donated by individuals who care about the success of the pool. Currently the most important need is a new roof. As many know, it leaks like a sieve. Several fundraiser parties have been held at the pool this year in an effort to raise funds for this project. Over the years shade screens and awnings have been added, the pavilion was enclosed, areas have been concreted, and the snack bar renovated. Walls, tables, and signs have been painted and re-painted. A few years ago one of the pool members graciously hand painted spectacular wall murals. These underwater saltwater scenes are amazing!

The current board president is Doug Mounter. He's so committed that on almost any given day for the past several years you'll see him at the pool doing one task or another. The phone number for White Towers is 801-572-DUNK and the website is www.whitetowersswimmingclub.com. We've been having fun since '61 so come out and join us! We're family approved and you won't find a better way to beat the heat.
